

IJL AUDITOR REPORT

Dear IJL AUDITOR,

this document has been organized to help you fulfill your duties at any IJL affiliated Event.

Auditing an IJL affiliated event:

Event organizer should have contacted you personally to check with your availability and willingness to operate. Though being the chosen auditor it is a good idea to operate with assistance from other auditors attending the event if that is the case. Their names may be recorded but only the appointed auditor fills the report file.

Preparation:

- Read (printing is a good option) the Event Affiliation File available from IJL web page Tournaments Section.
- Print this Report file to have it at hand at the event.
- Always have IJL affiliation forms at hand for requests a new affiliation prior to the event.

At the event:

- The Auditor represents the IJL, but DOES NOT run the event.
- New Affiliation forms are to be filled prior to competition start.
- The Auditor observes that the affiliation form is respected in rules and logistics.
- Should the Auditor be requested to confer with marshal or organizer, his opinion should represent a IJL policy potentially enforced at other events... in a different environment.

After the event:

- Auditor collects final standings/scores from Organizer/Marshal
- Modifications to original affiliation file should be noted on the report.
- Auditor's report focuses on LOGISTICS (compliance), FAIRNESS (competition) and SAFETY (individual, horses)
- Auditor report is to be submitted to IJL BOR and BOA within 21 days of the event.
